WEIRTON INDEPENDENCE DAY PARADE GENERAL RELEASE OF ALL CLAIMS

PARTICIPANT intends to participate in the WEIRTON INDEPENDENCE DAY PARADE held in and on the downtown streets of Weirton, WV on Saturday, July 1, 2023, sponsored by the City of Weirton.

PARTICIPANT acknowledges that he/she has read and understands all of the rules and regulations promulgated by SPONSORS governing the PARADE, attached hereto as "Exhibit A".

In consideration of the right to act as a PARTICIPANT in the PARADE, and my desire to voluntarily do so, PARTICIPANT hereby agrees as follows:

1. PARTICIPANT, as well as his/her heirs, officers, agents, servants, and employees, hereby releases and forever discharges SPONSOR, as well as its insurers, officers, agents, servants, employees, subsidiaries, and corporate sponsors, from any and all demands, claims, actions or causes of action, of any kind of description, for relief of any kind and nature, as a result of any damages and/or injuries arising out of being a participant in the PARADE.

2. PARTICIPANT acknowledges and agrees that PARTICIPANT assumes the risks of participating in the PARADE, including damage to property and personal injury to PARTICIPANT and that neither he/she nor anyone on PARTICIPANT'S behalf will seek compensation from SPONSOR for any claim, rights or damages arising out of participation in the PARADE.

3. PARTICIPANT hereby represents and agrees that he/she will indemnify and hold SPONSOR harmless from all liability and damages from any actions, causes of action, claims, and demands made by any parade spectators and/or other participants in the PARADE, arising out of any claimed injury and/or damages which may arise out of or in connection with my participation in the PARADE.

4. I, acknowledge and understand that the City of Weirton Board of Park and Recreation Commissioners are taking every reasonable measure to ensure the safety of all parade participants and spectators, but that no measures completely eliminate the risks of contracting COVID-19 through my participation in this event or exposure to other participants who may be carrying the virus.

5. PARTICIPANT agrees to not throw candy or other objects from moving vehicle toward spectators. It is strongly suggested that all candy be handed to spectators along the parade route.

PARTICIPANT has fully read and considered the terms of this General Release of All Claims, which is legally binding document, is satisfied with its terms and signs it of his/her own free will and accord.
